18<sup>th</sup> Avenue between County Road W and 162<sup>nd</sup> – widen and put shoulders down this year, replace culvert and raise the base up 8" with gravel, mill it, let it sit and then put hardener on it-if that works it will be blacktopped this fall, otherwise if it doesn't harden it will sit over the winter and get blacktopped next year, there is a possibility they can put some sort of mat under the road to help with water control as the road is very wet

160<sup>th</sup> has a culvert that will get replaced, we will get county aid to pay for half, our half is around \$9,000

Motion by Kerry and 2<sup>nd</sup> by Bob to accept the CSM for Donald & Nola Weber to split parcel.

Discussion regarding Western WI Biogas project – Motion by Bob and 2<sup>nd</sup> by Kerry NOT to take over the driveway now existing as a part of the rideshare south of I-94. All in favor, motion carried.
