Town of Pleasant Valley Monthly Board Meeting

The monthly meeting for the Town of Pleasant Valley was held on Wednesday, August 15, 2018 at 7:45 PM. Chairman Nolte called the meeting to order. All in attendance sited the Pledge of Allegiance.

Motion by Bob and 2<sup>nd</sup> by Kerry to approve the agenda as published with the exception of moving Mr. Hall (animal catcher) to the top of the list.

Darel Hall gave a presentation on an animal humane contract to take care of stray animals in the township. Contract would entail charges on an as needed basis and would be \$20 per hour plus mileage. He would deal with calls from dispatch and any issues relating to inhumane treatment of animals. No action taken on the matter.

Motion by Kerry and 2<sup>nd</sup> by Bob to adopt the Town Transportation Resolution #2018-1.

Motion by Kerry and 2<sup>nd</sup> by Bob to change the CSM for Donald & Nola Weber to change lot #3 to a non-buildable outlot.

Motion by Kerry and 2<sup>nd</sup> by Bob to approve the CSM for HR & Ruth E-Etal Nolte of 10 acres rezoned to outlot 1 on 170<sup>th</sup> St.
