Motion by Curtis and 2<sup>nd</sup> by James to approve the driveway permit presented by Steve Schalla/Bomaz Farms with the stipulation that the old driveway comes out so the new driveway is 200 feet from an existing driveway.

Megan Miller read the minutes from the February 2022 monthly board meeting. Motion by Curtis and 2<sup>nd</sup> by James to accept the clerk's report as read. Carried.

Michael Patrin attended the meeting to request an extension on his building permit for 1517 County Road N for one year from March 8, 2022. Motion by James and 2<sup>nd</sup> by Curtis. Motion carried.

Discussed parts of a proposed animal ordinance for further change and tabled the rest to a future month.

Road drive is scheduled for April 16, 2022 at 8 AM.

Discussed hiring the County for estimated road maintenance, including but not limited to blacktopping 170<sup>th</sup> between 18<sup>th</sup> and 30<sup>th</sup>, 2 days of crackfill, spraying roadways for wild parsnips and mowing the ditches.
