Monthly Board Meeting

Chairman Licht called the board of review meeting to order and adjourned to June 3, 2021. Motion by James and 2<sup>nd</sup> by Kerry.

The monthly meeting for the Town of Pleasant Valley was held on Tuesday, May 11, 2021 7:40 PM. Chairman Licht called the meeting to order. All in attendance sited the Pledge of Allegiance.

Chairman Licht read the agenda. Motion by James Shearer and 2<sup>nd</sup> by Kerry Licht. Motion carried.

Clerk read the minutes from the April 2021 monthly board meeting. Motion by James and 2<sup>nd</sup> by Kerry to accept the clerk's report as read. Carried.

Financial report by Treasurer: checking \$306,469.11; cemetery CD \$2,605.88; General CD's \$13,386.00. Motion by James and 2<sup>nd</sup> by Kerry to accept the treasurer's report. Motion carried.

Motion by James and 2<sup>nd</sup> by Curtis to fix the roads as the County recommended, which includes roughly 3 miles of chipsealing on 171<sup>st</sup> street to Z, 172<sup>nd</sup> street to 60<sup>th</sup> Ave, 57<sup>th</sup> Ave to 172<sup>nd</sup>, 59<sup>th</sup> Ave to 172<sup>nd</sup> St, 60<sup>th</sup> Ave to Cty Rd J, Steeple Drive from W to Town Line, 35<sup>th</sup> ave from Cty Rd W to 162<sup>nd</sup> Street; replace culverts on 170<sup>th</sup> between 18<sup>th</sup> Ave ave 30<sup>th</sup> Ave; wedge and overlay 158<sup>th</sup> Street, pulverize and spread gravel on 22<sup>nd</sup> Ave, approximate costs \$110,000 with partial reimbursement for a culvert from County Aid.

CSM for Herman Heinbuch was denied due to not meeting minimum lot size requirement.

Motion by Curtis and 2<sup>nd</sup> by James to hire Loberg Law Offices to handle future legal issues.

Motion by Curtis and 2<sup>nd</sup> by James to approve and pay the following orders. Motion carried.
