CORRECTED MINUTES

The Annual Town Meeting for the Town of Pleasant Valley was held on Tuesday, April 15, 2025 at 7:15 PM at the Town Hall. Chairman Licht called the meeting to order. Megan Miller as recording secretary. Those in attendance were Kerry Licht, Tom Zwald, Curtis Dunn, Deborah Volkert, and Megan Miller, and numerous Town residents including Larry Nolte, Tom Brunshidle, Darrell Dunn, Shirley Shearer, Mara DeBoe, Amber Rixmann, and others.

Chairman Licht read the agenda; motion by Curtis and 2<sup>nd</sup> by Tom to accept the agenda as read.

Annual minutes were read from the 2024 annual meeting. Motion by Tom and 2<sup>nd</sup> by Curtis to accept the clerk's minutes as read.

Clerk Megan reported on the 2024 Financial Report. Motion by Tom and 2<sup>nd</sup> by Curtis to accept the 2024 Financial Report. Motion carried.

Motion by Curtis Dunn and 2<sup>nd</sup> by Tom Zwald to continue to use the River Falls State Bank as the official depository for the town.

Motion by Tom and 2<sup>nd</sup> by Curtis to purchase a size 2 PO box in Hammond to be used primarily for the treasurer's mail. Motion carried.

Motion by Tom Zwald and 2<sup>nd</sup> by Curtis Dunn to allow the Town board authority to set the Annual Tax Levy in the fall of 2025. Motion carried.

Annual meeting for 2025 will be the 3<sup>rd</sup> Tuesday, April 21, 2026.

Motion by Tom and 2<sup>nd</sup> by Curtis to approve a liquor license application due date to the Town Clerk on a date between the 1<sup>st</sup> Tuesday in May through the 2<sup>nd</sup> Monday in May.

Motion by Tom and 2<sup>nd</sup> by Curtis to motion for liquor license applications in the Baldwin Bulletin. Motion carried.

Motion by Darrell Dunn and 2<sup>nd</sup> by Shirley Shearer to look at finding out what it would cost to erect a new town hall structure for the Town of Pleasant Valley. Motion carried.

Motion by Tom Brunshidle and 2<sup>nd</sup> by Larry Nolte to evaluate the cost of repairing the current town hall building to meet the requirements of the ADA and make the building sound. Motion carried.

Motion by Tom Brunshidle and 2<sup>nd</sup> by Larry Nolte to establish a building committee that explores options for building a new town hall and for repairing the existing hall. Motion carried.

Motion by Kerry Licht and 2<sup>nd</sup> by Thomas Zwald to adjourn the annual meeting.
