

**ORDINANCE # 2026-06
AMENDMENT TO BUILDING PERMIT REQUIREMENTS
TOWN OF PLEASANT VALLEY**

The Town Board of the Town of Pleasant Valley, St. Croix County, Wisconsin, does hereby ordain as follows:

ORDINANCE 2025-03, BUILDING PERMIT REQUIREMENTS, is hereby amended as follows:

SECTION 2. CONSTRUCTION STANDARDS AND CODES ADOPTED.

Buildings and other construction must conform to the Wisconsin Uniform Dwelling Code (UDC), Chapters SPS 320-325, its successors and all amendments thereto, in effect at the time of construction. Chapters SPS 320-325 are hereby adopted for enforcement by the building inspector.

Additionally, the following Wisconsin Administrative Codes, their referenced codes and standards, and subsequent revisions, are adopted for enforcement by the building inspector, who shall be certified, as appropriate, by the State of Wisconsin.

Chapters SPS 360-366	Wisconsin Commercial Building Code
Chapters SPS 375-379	Buildings Constructed Prior to 1914 Code
Chapter SPS 316	Electrical
Chapters SPS 381-387	Plumbing
Chapter SPS 327	Camping Units

All other SECTIONS of ORDINANCE 2025-03 remain unchanged.

This amendment shall become effective following publication and/or posting in the manner set forth in Wis. Stat. §60.80.

ORDINANCE # 2025-03
BUILDING PERMIT REQUIREMENTS
TOWN OF PLEASANT VALLEY

WHEREAS, the Town Board of the Town of Pleasant Valley, St. Croix County, Wisconsin, has authority under Wis. Stat. §101.12 to exercise jurisdiction over the construction and inspection of new dwellings consistent with Chap. 101; and

WHEREAS, the Town Board of the Town of Pleasant Valley, St. Croix County, Wisconsin, finds it necessary to establish its present requirements to obtain building/construction permits; and

NOW THEREFORE, the Town Board of the Town of Pleasant Valley, St. Croix County, Wisconsin, does hereby ordain as follows:

SECTION 1. REQUIRED BUILDING PERMITS. A building permit is required for all new construction (homes, barns, sheds, garages, etc.), additions to existing building (including room, deck, porch, etc.), alterations to existing building (including finishing basement, bathroom, remodel, etc.), repair of existing building, razing existing building, moving existing building, and solar, fence, and sign installations.

SECTION 2. WISCONSIN UNIFORM DWELLING CODE. Buildings and other construction must conform to the Wisconsin Uniform Dwelling Code (UDC) in effect at the time of construction.

SECTION 3. APPROVAL OF TOWN BOARD PRIOR TO CONSTRUCTION.

(A) Prior to construction of a new building, whether the first building on the parcel or a subsequent building, the Town Board must grant an Authorization for Building Inspector to Issue Building Permit.

(B) The application for the Authorization for Building Inspector to Issue Building Permit shall be filed with the Town Clerk and accompanied by a schematic diagram showing the location of the building on the parcel with setbacks from the road and property lines, with adjacent buildings marked, and shall include an attestation that the building complies with the applicable dwelling unit density ratio set forth in Sec. 5 D(3) of the Subdivision Ordinance of the Town of Pleasant Valley, No. 2005-01.

(C) The Town Board shall review the application prior to approval.

(D) There is no fee for the Authorization for Building Inspector to Issue Building Permit.

SECTION 4. COUNTY PERMITS. Any permit(s) required by St. Croix County must accompany the application for a driveway permit and/or building permit.

SECTION 5. REQUIREMENT OF PERMIT. If any of the required building permit(s) is not obtained prior to commencement of construction or installation, the building permit fees shall be doubled.

SECTION 6. DRIVEWAY PERMIT. Prior to any excavation or construction on the property, or use of an access route to the property that may traverse a ditch, a driveway permit must be obtained from the Town Board and a driveway installed as per the Town's Driveway Ordinance.

SECTION 7. BUILDING PERMIT FEE SCHEDULE. Fees for permits shall be based on the value of the work to be done. This value will be based on current costs of construction (materials and labor) as determined by the Building Inspector. The Permit Fee Schedule may be amended from time to time by Resolution of the Town Board.

SECTION 8. REVOCATION OF ANY PRECEDING ORDINANCE OR RESOLUTION. This Ordinance hereby revokes and supersedes any prior Resolutions or Ordinances adopted by the Town Board relating to the subject matter herein.

SECTION 9. EFFECTIVE DATE. This Ordinance shall become effective following publication and/or posting in the manner set forth in Wis. Stat. §60.80.

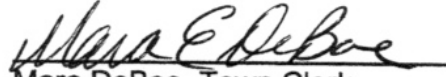
